### **PROCEDURE NOTE**

#### **STREET TRADING APPLICATIONS**

##### **Introductions**

1. The Chairman introduces him/her self and makes the following statement:-  

Presentations to this Sub-Committee are not given under oath. However, I would like to remind all parties that the highest standards are expected and any deviation from these high standards could possibly influence any decision of the Committee.
2. Chairman invites Sub-Committee Members to identify themselves.
3. Chairman introduces Councillors other than Sub-Committee Members (if any).
4. Chairman requests representatives of Legal and Democratic Services to identify themselves.
5. Chairman requests names of persons wishing to be heard by Committee, where appropriate:-

  - (7) Other Representors.

  - (5) Chief Executive Worcester BID

25. At the conclusion of the hearing all parties with the exception of Members of the Sub-Committee and the representatives of Legal and Democratic Services requested to leave the room to enable the Sub-Committee to consider and determine the application.
26. All parties may be recalled if the Sub-Committee seeks clarification on any point to enable it to come to a determination. All parties with the exception of the Members of the Sub-Committee and the representatives of Legal and Democratic Services will then be required to leave the room.
27. All parties will be recalled and the Chairman will announce the decision of the Sub-Committee together with reasons for that decision, together with, if appropriate, any conditions to be attached to the grant of any Licence.
28. The decision of the Sub-Committee will be confirmed in writing to the Applicant within seven working days of the hearing.
