Dear Sir / Madam

I wish to object against the granting of this licence on the grounds of the Prevention of Public Nuisance.

We are already receiving numerous complaints from residents of the nearby flats, which are complaining about noise levels from the adjacent Arch Rival premise which is adjacent to Sangers and also in very close proximity to the residential properties.

These complaints, which relate both to noise before 23:00hrs, and from events licenced by TENs have been evidenced, and any permission given to Sangers to licence them beyond 23:00hrs as they are requesting will very clearly cause unreasonable distress and will very likely result in unnecessary formal action against the premise on the grounds of Nuisance.
